You are hereby notified that Bank of America, N. A. of North Carolina, a national banking association with a principal place of business at 100 N. Tryon Street, Charlotte, NC 28255 has filed with this Court a petition, alleging that:

1. The defendant, Guaranty Residential Lending, Inc. was a Nevada Corporation having as of November 12, 2001 a principal place of business at 1300 South Mopac Expressway, Austin, Texas 78746. Said company is no longer active, having merged into Guaranty Bank in November 2007 according to the records of the Secretary of State of the State of Nevada.
2. According to the Office of Thrift Supervision, Guaranty Bank is no longer active, having been closed on August 21, 2009. The Federal Deposit Insurance Corporation was named Receiver of said bank.
3. On October 12, 2001 Jennifer J. Malone and Arthur F. Silva, Jr. granted a mortgage for \$38,500.00 to Guaranty Residential Lending, Inc., registered October 12, 2001 as Document No. 1185794 on Certificate of Title No. 222689, describing land shown on Land Court Plan No. 3806-B.
4. Petitioner is the holder by assignment from Guaranty Residential Lending, Inc. and has standing to bring this action.
5. For reasons unknown to Petitioner said assignment was never recorded in the South Middlesex Registry District and is now lost, its whereabouts being unknown to Petitioner.
6. Said mortgage has been fully paid and the obligations imposed thereby have been discharged, but as a result of the missing assignment the mortgage cannot be discharged of record.

Wherefore Petitioner prays that:

1. Appropriate notice by publication be provided to Guaranty Residential Lending, Inc., its successor Guaranty Bank.
2. Certificate of Title No. 222689 be amended by expunging the mortgage registered as document 1185794.

It is **ORDERED**:

1. that a copy of the above be mailed by certified mail to all above named parties.
2. that the plaintiff serve this notice by publishing the same one time in the Wakefield Daily Item a newspaper published/circulated in Town of Wakefield, in the County of Middlesex and said Commonwealth twenty-one (21) days before said return day.

If you desire to make any objection or defense to said complaint, you or your attorney must file a written appearance and an answer under oath setting forth clearly and specifically your objection or defense to each part of said complaint in the office of the Recorder of this Court at 226 Causeway Street, Boston, MA 02114 on or before July 17, 2017.
