Sealed Bids will be received by Wakefield Municipal Gas & Light Department (WMGLD), the Awarding Authority, (hereinafter referred to as Owner) under the provisions of Chapter 164 Section 56D inclusive of the Massachusetts General Laws, as last revised, for:

15kV Pad-Mounted SF6 Switchgear Contract

Sealed Bids will be received at the Wakefield Municipal Gas & Light Department, 480 North Ave., Wakefield, Massachusetts 01880, until 11:00 AM (EST) on Tuesday, March 17th, 2020. Bid Forms and Documents may also be obtained from the Purchasing Department, WMGLD, 480 North Ave., Wakefield, MA 01880 or by requesting documents via email to Sara Eriksen, seriksen@wmgld.com beginning on Tuesday, February 18th, 2020 at 7:30 AM (EST). Bids must be received in duplicate in a sealed envelope marked "**15kV Pad-Mounted SF6 Switchgear**". The said Bids will be opened publicly and read aloud at the Wakefield Municipal Gas & Light Department, 480 North Avenue, Wakefield, Massachusetts 01880, at 11:00 AM (EST) on Tuesday, March 17th, 2020. "LATE BIDS WILL NOT BE ACCEPTED".

Each Bid shall be accompanied by Bid Security in the form of a Certified Check, or a Treasurer's/Cashier's Check, issued by a responsible bank or trust company, payable to the Wakefield Municipal Gas & Light Department. The sum being not less than five percent (5%) of the amount of the Bid or accompanied by a Bid Bond in like amount of a corporate surety licensed to do business in the Commonwealth of Massachusetts. Each Bid shall be conditioned that the Bidder will pay Wakefield Municipal Gas & Light Department, as liquidated damages, the amount specified in the bond if WMGLD selects the Bid as submitted and the proposer fails to enter into a contract with WMGLD in accordance with its Bid.

Complete instructions for filing Bids are included in the Instructions to Bidders. Every Bid shall be submitted in full accordance with those Instructions to Bidders. Bids shall be valid only when accompanied by each of the following: (1) a fully completed and properly executed "Bid Form", (2) Bid Security and (3) any other data that may be identified in the Instructions to Bidders or Bid Form as required with the bid.

No Bidder may withdraw his Bid for a period of ninety (90) days (Saturdays, Sundays and Legal Holidays excluded) after the actual date of the opening of the General Bids.

Wakefield Municipal Gas & Light Department reserves the right to reject any or all Bids if deemed in the best interest of Wakefield Municipal Gas & Light Department and the Town of Wakefield, Massachusetts.
